



GLOBAL POLYGRAPH NETWORK

REQUIREMENTS FOR PARTICIPATING GPN EXAMINERS:

1. GPN examiner must have completed an accredited polygraph training program.
2. GPN examiner must be certified (if certification is available from that school)
3. GPN examiner must possess a valid polygraph license in locations requiring licenses
4. GPN examiner must have conducted at least 300 specific-issue examinations.
5. GPN examiner must have conducted at least 50 relationship-type examinations.
6. PN examiner must submit to us with this application (a) a current Curriculum Vitae and (b) charts and question list from a recent exam (within the past 30 days)
7. GPN examiner must use a polygraph instrument with at least 4 recording channels.
8. GPN examiner must maintain an email address which is checked daily to receive Network referrals.

FEES, CONDITIONS AND REQUIREMENTS:

1. Client pays GPN a \$100.00 non-refundable deposit per exam (or \$250.00 per day). Outside the U.S. GPN collects 25% of the fee as a deposit. This is GPN's referral fee. If any future work is done for this client, this referral fee is due GPN..
2. GPN will email the referral information to the participating network examiner.
3. GPN examiner will contact the client within 2 business days to make the appointment.
4. GPN examiner will offer the client an exam date within 30 days of assignment.
5. Exams may not be conducted by any examiner not approved in writing by GPN.
6. GPN examiner will charge a predetermined (set) fee less the GPN deposit.
7. Extra fees may be charged for testing on evenings or weekends.
8. Typewritten reports must be furnished to the client at no additional charge.
9. GPN examiner must advise us by fax or email when the exam has been completed.
10. GPN examiner must fax or email client's signed credit card authorizations to GPN
11. GPN examiner will provide assistance in resolving payment and credit card disputes.
12. If GPN Examiner has a web site, he/she must provide a link to www.polytest.org
13. GPN examiner must complete at least 16 hours of polygraph CE credits every 2 years.
