I was the point of contact for local foreign consulates and media. I trained new employees on ethics and integrity practices and delivered essential briefings to senior officials. I maintained a 91% efficiency rate in conducting employee and civil rights inquiries.

I directed inquiries within numerous agencies within the U.S. Department of Justice. I have conducted polygraph examinations throughout the Southwest of the United States and for other federal agencies in foreign countries. My cases generally involved public corruption and criminal and civil rights investigations. I led training programs for agency employees and key agency leadership personnel to ensure full knowledge of investigative techniques and practices such as interrogation and forensic methodology. I have provided training on public integrity for immigration officers and performed advanced internal audits and investigations. While working for the U.S. Department of Justice, I conducted over 200 specific issue polygraph examinations and investigations at facilities classified as maximum security within the U.S. Bureau of Prisons. I have conducted polygraph examinations for AFOSI, FBI, DEA, US DOJ, state agencies, and foreign governments.
